

How to apply to the Access to Elected Office Fund







Easy Read







What is the Fund for?



The Access to Elected Office Fund helps to get rid of things that make it harder for disabled people to **stand for election**.

These things are called barriers.



Standing for election means asking people to vote for you to represent their local area:

- as a councillor
- as a Member of the Scottish Parliament (MSP)



The Fund gives money to cover the extra costs of standing for election that non-disabled candidates would not have.



This gives disabled people a more equal chance to take part in politics.

Check if you can apply to the Fund



To apply for the Fund you must:

 be disabled as it is described in the Equality Act 2010



The Equality Act protects people from discrimination and helps to make sure people are treated fairly.

- have said that you will either:
 - want to be selected for an election covered by the Fund
 - have been selected
 - plan to stand as an
 independent candidate this
 means you are not representing
 any political party



• follow the rules for elections



The Fund opens before each election it supports.

Ask Inclusion Scotland for advice if you are not sure if the Fund is open for applications.

What you can claim for



The Fund can cover costs linked to your campaign including:

- assistive technology this means products or services that help disabled people live as independently as possible
- coaching this means working with a person to support you to deal with any barriers



- personal assistance
- travel costs







Inclusion Scotland can give you advice if you are not sure if something would be covered by the Fund

Step 1: Contact Inclusion Scotland

A member of the Participation team will:

- guide you through the process
- answer any questions you may have
- arrange a time for your application meeting



You can discuss what you need and ask for any **adjustments** that you need at any time.

Adjustments are changes employers must make to give a person who is disabled the same chance as anyone else to get and do a job.

Step 2: Attend your application meeting





You will be invited to a meeting with an Inclusion Scotland staff member by video call or telephone.



This meeting will last between 45 minutes to an hour.



You can bring someone with you to support you.









This meeting is a chance to:

- learn more about Inclusion Scotland and the Fund
- talk about:
 - o your campaign plans
 - o what you need to stand for election
 - o what things make it difficult for you to stand for election
- think about what support would make the biggest difference to your campaign

You do not need to prepare anything but it is useful to think about:

• the campaigning activities you plan to do



- the barriers you might face when campaigning
- any support that has worked well for you before



After the meeting you will be sent 4 forms:

Data Protection and Equalities
Monitoring forms - to be filled in by you



- Application form this will be partly filled out at the meeting with a few bits for you to fill in afterwards
- Recommendations letter this is drafted by Inclusion Scotland based on what you talked about at your meeting



The recommendations letter is sent to you to agree before it goes to the Decision Panel.



You can ask for changes as many times as needed until you are comfortable with the support being suggested.

Step 3: Wait for the review of the Decision Panel



After you have sent in your forms and agreed with your recommendations letter your application will be **anonymised** and sent to the Fund's Decision Panel for **review**.




Anonymised means it will not have your name on it or have any way to tell it is about you.



Review means the panel will check over the form and make a decision.





what makes campaigning difficult for you

The panel is a small group of independent

- if the support in your recommendations letter is correct and is linked to your campaign work
- how the award would support you to take part in the election in the same ways as non-disabled people







The panel make sure that funding decisions:

- treat everyone fairly and equally
- give people what they need
- follow the rules of what the Fund is for

Step 4: get your award outcome – what decision has been made



When the Decision Panel has checked your application they will tell you the outcome.

If your application is approved you will be given details of your award and how it will be set up.



If your application is not approved you will be told why.

If you would like to try again to get funding you can work with Inclusion Scotland to make changes to your application and send it in again.

Step 5: Use your award



How you use your award will depend on the type of support that has been agreed for you.



Inclusion Scotland will work with you to make sure your award is set up in an easy way and that it gives you what you need.



You will have review meetings with Inclusion Scotland from time to time.

The timing of these reviews will be set out in your recommendations.



The meetings:

- usually take place every 4 to 6 weeks or at the end of campaign blocks
- make sure your award is working well so that it is:
 - o not more than you need
 - o giving enough support



Types of support





You may be invited to a needs assessment where a specialist will recommend what machines, equipment or information would be best for you like:

- physical equipment
- specialist software
- app subscriptions



If you already know what works best for you the fund can usually provide it without an assessment.



Coaching

You may attend coaching sessions with staff who will help you deal any barriers you have and what you need.



Communication support

When taking part in meetings, events, or speaking to people you want to vote for you, you may be able to get support from:

- British Sign Language interpreters
- electronic notetakers
- lipspeakers
- speech-to-text reporters



Inclusion Scotland can help you to find and book the right communication support that you need.



Personal assistance



Personal assistance is usually arranged through the Glasgow Centre for Inclusive Living, Lothian Centre for Inclusive Living, or another provider in your area.



Some applicants hire their own support if background checks have been done.

Inclusion Scotland will support you through this process but will hire Personal Assistants for you.





Depending on your travel needs:

- a taxi account may be set up with a local company so you do not need to pay when you travel
- you may be given an allowance for public transport
- you may get money back for driving costs



Step 6: Take part in our evaluation



Your experience of the Fund is very important.

Evaluation helps us understand:



- what works well
- what could be made better
- how the Fund is making a difference for disabled candidates in Scotland





At different parts of your Fund journey we will ask you to fill out short surveys to find out what you think:


- about the support you received
